

RV PARK CAMPGROUND REGULATIONS

Running Aces Casino provides 20 recreational vehicle camp sites in the Stable area. The sites are intended for use by horsemen, horsewomen, horse owners, trainers or other hired staff who actively participate in the Running Aces meet and who are licensed by the Minnesota Racing Commission.

Running Aces provides electricity, cable access, water, and sanitation hook-ups for the removal of black and gray waste from the holding tanks of each RV unit. All vehicles using the RV sites must be equipped with self-contained toilet facilities.

Toilet and shower facilities are provided and are accessible in each Stable barn. Laundry machines are available inside the Barn A building.

Persons who are registered for RV use are considered Guests. Any person who intends to reside in the RV must be licensed by the MRC (Minnesota Racing Commission). MRC rules establish 16 years of age as the minimal age for licensure. Use of the RV sites is subject to the following rule and requirements:

- The number of persons residing in each RV shall not exceed 2 non-related persons or more than 4 family members.
- No visitors are permitted after 12:30 AM.
- Waste/sewage, water, or effluent from sinks, portable toilets or other plumbing fixtures must be deposited through use of the site sanitation hook-up. None of the above mentioned substances may be deposited directly on pavement, dirt or vegetation.
- Waste storage tanks must be maintained and used according to manufacturer's recommendations. This includes the use of RV approved toilet paper and waste water treatment chemicals. Waste tanks are to be left in the closed position.
- All RV's must keep their wheels on while using the RV parking sites.
- Pets, other than cats, are not permitted in the Stable area.
- Quiet hours are from Midnight to 5:00 A.M. daily. Sounds from speakers, radios or Televisions, other auditory devices etc., or other machinery must not be heard beyond the RV parking site or disturb other RV park users.
- The use of T.V.'s speakers, radio or other audio devices located outside of the trailer is not permitted after 8:00 P.M. on non-racing nights and after 5:00 P.M. on racing nights. Any complaints regarding the use of such equipment received from other RV Guests will result in a prohibition of the use of the equipment.
- Persons residing in the RCA shall not be in any of the barns after midnight other than for just cause. (Caring for a sick animal, helping contain a loose animal, etc.)
- No off-road, all-terrain or other unlicensed motorized vehicles are permitted in the Stable area parking area.
- Campfires are not permitted in the camping area.
- Tents are not permitted in the RV Park.
- RV sites must be kept clean and orderly as determined by Running Aces management. All trash is to be placed in the trash receptacles provided for RV users.
- Absolutely no firearms, fireworks, explosives or weapons of any kind are permitted in the Stable area.

- Absolutely no illegal drugs or controlled substances as defined in Minnesota State Statutes are allowed in the RV Park.
- No laundry or harness racing gear shall be hung, affixed or displayed within the RV parking stall.
- Guests are expected to keep their trailers and the immediate area around the trailer in a neat and clean manner.
- Guests are expected to monitor weather conditions and retract awnings during potential threatening situations.
- Running Aces reserves the right to conduct inspections of its trailers. Damages that are not the result of normal wear and tear will be repaired at a cost to the leasee.
- Running Aces reserves the right to evict or refuse entry to any person who has evidenced a disregard for the safety of others, violates RV park rules, or any other rule or regulation applicable to either Running Aces Casino and Racetrack or the Minnesota Racing Commission.
- Patrons of the RV Park use the Park at their own risk.
- Running Aces is not responsible for damage, injury or loss to persons or property residing in the RV Park.
- Running Aces reserves the right to change its rules and regulations at its sole discretion as deemed necessary.
