Leg One: Sunday, June 4th Claiming Price \$3,500 (plus all allowances) Purse \$5,000

Leg Two: Sunday, June 11th Claiming Price \$4,000 (plus all allowances) Purse \$6,000

FINAL: Sunday, June 18th Purse \$12,500

Nominating Fee: \$200 Due May 15th

All horses eligible to be claimed in Leg One and Leg Two. No claiming in FINAL.

Late Closer #6

The Bestdealintown Pacing Claiming Series

Leg One: Tuesday, June 6th Claiming Price \$3,500 (plus all allowances) Purse \$5,000

Leg Two: Tuesday, June 13th Claiming Price \$4,000 (plus all allowances) Purse \$6,000

FINAL: Sunday, June 18th Purse \$12,500

Nominating Fee: \$200 Due May 15th

All horses eligible to be claimed in Leg One and Leg Two. No claiming in FINAL.

Running Aces 2017 Late Closers – Conditions & Entry Form

- 1) All horses must meet current qualifying standards at Running Aces at time of entry and be released from the Stewards and Vet Lists.
- 2) All nominating fees made payable to Running Aces Casino & Racetrack and are due at time of entry. There are NO Starting Fees and all Final purses are guaranteed.
- 3) In events #2, #3, #4, #5 and #6, Running Aces requires 7 separate betting interests in any preliminary Leg, or it may be cancelled.
- 4) In events #2, #3 and #4, the conditions for those races are as stated as of and through May 1st. There are no additional allowances for Minnesota Bred horses entered in those Late Closers.
- 5) In events #5 and #6, Minnesota Bred horses will still receive the 50% claiming allowance they are afforded in all claiming races conducted at Running Aces.
- 6) In events #2, #3, #4, #5 and #6, the top NINE money earners in those Series that enter shall comprise the field for the Finals.
- 7) In events #5 and #6, horses are eligible to be claimed in both Leg One and Leg Two. There is no claiming in either Series Final.
- 8) In events #2, #3, #4, #5 and #6, no owner and/or trainer may start more than TWO horses in those Series Finals.
- 9) In events #2, #3, #4, #5 and #6, the \$200 Nominating Fee is due May 15th. Entries postmarked by May 15th will be accepted.
- 10) In event #1, the \$350 Nominating Fee is due June 19th. Entries postmarked by June 19th will be accepted. A Supplemental Entry and the Fee of \$3,000 is due at time of entry.
- 11) Running Aces reserves the right to cancel any event if sufficient entries are not received. In that case, all Nominations Fees will be returned to the nominators.
