# RUNNING ACES CASINO & RACETRACK CUSTOMER SELF-EXCLUSION REQUEST

You have voluntarily requested that the Running Aces exclude you from gaming services on their premises. Your request for self-exclusion will be effective for a minimum period of twelve (12) months from the date of execution and applies to ALL of Running Aces property.

We are pleased to take steps to accommodate your request. However, the Running Aces is not undertaking any legal obligation to deny those services to you. The responsibility to refrain from gaming at Running Aces is yours. If you are caught gambling at Running Aces you will be escorted from the gaming floor and may be charged under Minnesota State statute 609.605 "Trespassing".

If you are found to be on any of Running Aces property while this document is in effect, you may be evicted as a trespasser and Running Aces may assert any legal rights (both criminal and civil) against you as a trespasser. If you manage to gain access to any of the Running Aces Properties while this document is in effect, by signing below, you hereby acknowledge your status as a trespasser and you hereby agree not to assert and to waive any claims against the Running Aces which may be related, in any way, to your presence on the property.
