



Halloween Costume Contest Rules

By entering the Contest, you agree to be bound by these Official Rules and to comply with all applicable laws and regulations.

PRIZES: 1st Place- \$200, 2nd Place- \$125, 3rd Place- \$75

HOW IT WORKS: No need to pre-register to be judged, just put together a creative, fun, spooky or imaginative costume and wear it to the party. A panel of judges will parade through the room and select what they feel are the 5 best costumes. Those 5 selected contestants will be notified by 10:45pm. At 11pm, the 5 selected contestants will be brought to the stage to be judged a second time, this time using audience applause. Our DJ will MC this second round of judging and will crown our 1st, 2nd and 3rd Place Winners.

ELIGIBILITY AND JUDGING: Costumes will be judged on creativity, composition and acceptable standards of costume design. The judges are a panel of Running Aces staff members. Judges shall determine winner eligibility in its sole and absolute discretion. All decisions made by the judges are final.

COSTUME RESTRICTIONS: Entries must not contain anything that is or may be: (i) threatening, harassing, degrading or hateful; (ii) defamatory; (iii) fraudulent or tortious; (iv) obscene, indecent or otherwise objectionable; (v) deemed to cause feelings of disharmony, enmity, hatred or hostility between different religious or racial groups; (vi) protected by copyright, trademark, patents, utility models, design patents or other proprietary right without the express prior written consent of the owner of such right; or (vii) dangerous or potentially dangerous, or that would encourage dangerous behavior from viewers, such as use of explosives and/or harmful substances; or (viii) contrary to governmental policies of any country whose residents are eligible to enter the Contest. **No Masks, No Face Paint that covers the face, No Hoods, No Nudity, No Weapons, No Props (examples; sticks, light sabers, bags, anything that could be used as a weapon or to conceal weapons or other prohibited items.)No liquids, gels, or other substances which could cause a mess or a safety hazard on the course are allowed. Must be at least 18 years of age. Contestants violating these rules will be immediately disqualified.**

USE OF NAME, LIKENESS, ETC.: By entering the Contest, you hereby acknowledge and agree that Running Aces shall have the unlimited right to use and publish your name, voice, city, state, likeness, photograph, video, biographical and prize information, and other elements of your persona and identity, in all media now known or hereafter developed, for all purposes of this Contest, as well as for all general marketing, advertising, promotional, commercial tie-in, merchandising, and other business purposes of Running Aces, all without notice or compensation to you.

ENTRANT RELEASE: By entering this Contest, you forever release, indemnify, discharge, and agree to hold harmless, all Released Parties from any and all claims, causes of action, liabilities and damages: (a) for personal injuries, death, loss of or damage to personal property, and/or other harm or loss of any nature whatsoever sustained by anyone or anything in connection with your participation in the Contest;(b) for libel, defamation, invasion of privacy, violation of the right of publicity, infringement of copyright, or violation of any other personal or property right ; and/or (c) from any typographical, human or other error in the printing, offering, selection, operation or announcement of any Contest activity and/or prize.

ADDITIONAL CONDITIONS: Running Aces reserves the right to terminate the Contest if fraud, technical failures or any other factor beyond reasonable control impairs the integrity of the Contest as determined by Running Aces in its sole discretion. At its sole discretion, Running Aces may disqualify any person whom it considers to have intentionally violated the Official Rules or any element of the Contest. By participating, entrants agree: (a) to be bound by the Contest Official Rules and the decisions of the person or persons who select the winners, and (b) to release, indemnify, and hold harmless Running Aces, and each of their respective affiliates, subsidiaries, and independent contractors, and their respective directors, officers, employees, and agents, including advertising and promotion agencies, (collectively, "Released Parties") from any and all liability with respect to acceptance, possession or use (or misuse) of the prizes or participation in the Contest.

APPLICABLE LAW: These Official Rules are governed by the laws of the State of Minnesota without giving effect to conflicts of law rules.
